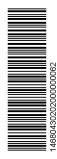

#### Elias D. Garcia - BIO

Elias is an experienced government affairs professional with over 7 years of experience, working primarily on state and local government issues. He most recently served as senior policy manager at the Los Angeles Area Chamber of Commerce, where he managed the Chamber's Transportation & Goods Movement and the Environmental, Water, & Energy policy councils. He was the lead staff member for the annual ACCESS LA lobby day, the Chamber's signature local advocacy event that fosters dialogue between Los Angeles City and County policymakers and business leaders to address issues and challenges facing the region.

Prior to his service at the Chamber, Elias served as the senior government affairs manager for the Associated General Contractors of California, where he led all government affairs efforts for the 9-county Southern California region. In this capacity, he regularly appeared before local government bodies advocating for the construction industry's interests. He regularly worked with all the major local transportation agencies, including working with one agency's senior staff on limiting the impact of a handful of proposals harmful to contractors.

Elias is a lifelong Angeleno. Except for a three year period when he served at the CA State Legislature as a Legislative Director, he has resided in and around the Silver Lake neighborhood. He has a Bachelor's degree in Political Science from California State University Northridge and is currently pursuing a Master of Public Administration from California State University Long Beach. In his free time Elias enjoys hiking and spending time with his niece and nephew.
